Entry Deadline: January 29, 2010

*White Stone Gallery announces a call to artists for the 2010 Juried Fine Art & Faith Exhibit, to be held March 5 - March 28, 2010 at the gallery's location in Philadelphia, PA. In addition to the exhibition in Philadelphia, accepted works will display online for one year. One piece will be the "Featured Selection" of the exhibit. One artist will receive a year contract as a represented artist with White Stone Gallery.*

**ELIGIBILITY:** All entries must be inspired by the Bible. Open to all U.S. resident artists at least 18 years of age. Eligible entries include all mediums, excluding digital, film, video and installations. All work must be the original work of the applicant, suitable for gallery installation and available for sale.

All 2D works should be framed or gallery wrapped with no visible staples on sides. All 2D work **MUST** be completely prepared for hanging. The maximum size limitation is 30 inches in height or width and is not to exceed 20 pounds including frame. For this particular exhibit, we are limiting all 3D work to be able to stand freely on a podium that is 18 inches square.

**ENTRY DEADLINE:** Submissions, accompanied by completed entry documentation and fee, must be received by email, mail or hand-delivered on or before 7:00 PM, January 29, 2010.

**FEES:** \$40 for 3 entries; \$5 for each additional entry. Nonrefundable. You have the choice of paying the fee using VISA, MASTERCARD, AMERICAN EXPRESS, DISCOVER, PAYPAL, MONEY ORDER or CASH.

**NOTIFICATION:** The names of the selected artists and their selected pieces will be posted on <http://www.whitestonegallery.com/exhibits/e-juriednews.php> on February 5, 2010. The status of the entries will not be discussed over the phone.

**ACCEPTANCE:** Artists whose works are accepted will need to ship their artwork to the gallery to arrive by February 26, 2010. In order to insure the quality of the exhibition, accepted works may be withheld from the exhibition at the juror's discretion. The juror's decision is final. Accepted works must remain on exhibit for the duration of the exhibit. In addition to the exhibition at White Stone Gallery's location, accepted works will display on White Stone Gallery's website for one year. One artist will receive a year contract with White Stone Gallery.

**SHIPPING:** The artist is responsible for shipping the selected submissions to and from the gallery. The artwork should arrive with a check or money order in the amount of return shipping. You may also call the gallery and place the return shipping amount on a credit card. If your work sells and there is nothing to ship back to you, the amount of return shipping will be included with your commission.

**SALES:** A 50% commission will be retained by White Stone Gallery on all sales. Works will be sold at the price indicated on the entry form.

**INSPIRATION:** Each entry requires brief comments describing the inspiration for the piece. Even though it is not necessary, adding a scriptural reference is appreciated.

1. All work will be judged electronically as images.
2. Print and fill out a copy of the form below.
3. You may send your images attached to an email or mail your images on a CD. If placing your images on a CD, label the CD with your name and phone number. CDs will not be returned. If attaching your images to an email, make sure you include your **AREA CODE AND PHONE NUMBER (no dashes) AS THE SUBJECT** in the email.   - a. Each 2D entry may have one image file. Each 3D entry may have two images. (Each image must show a different view of the 3D work.)
